The ornamental design for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a motorcycle showing my new design;

FIG. 2 is a right side view thereof;

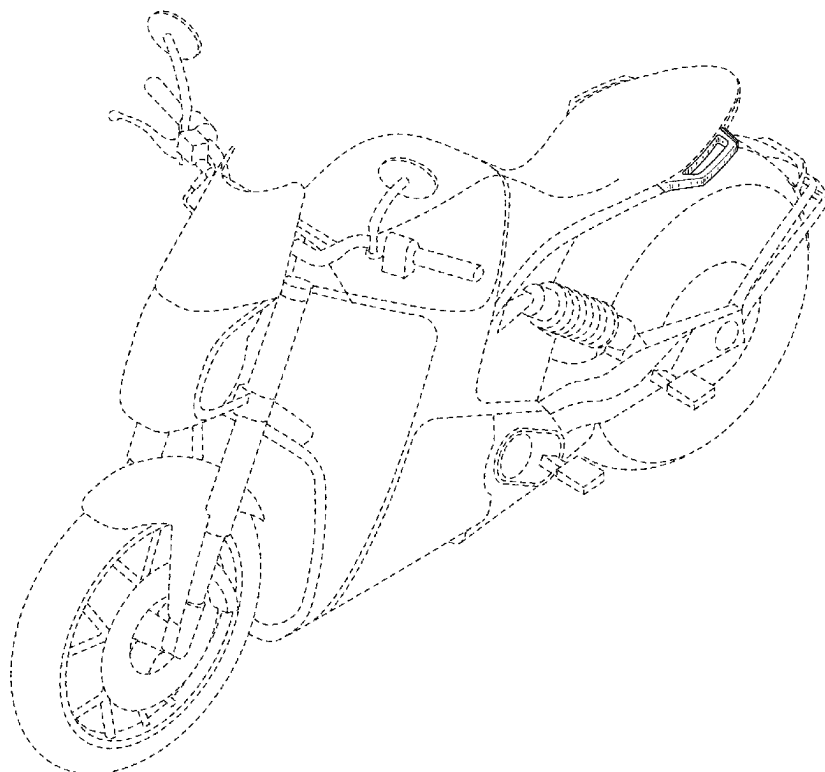
FIG. 3 is a top view thereof;

FIG. 4 is a rear right perspective view thereof; and,

FIG. 5 is an enlarged view of FIG. 4 with environment removed to enhance clarity.

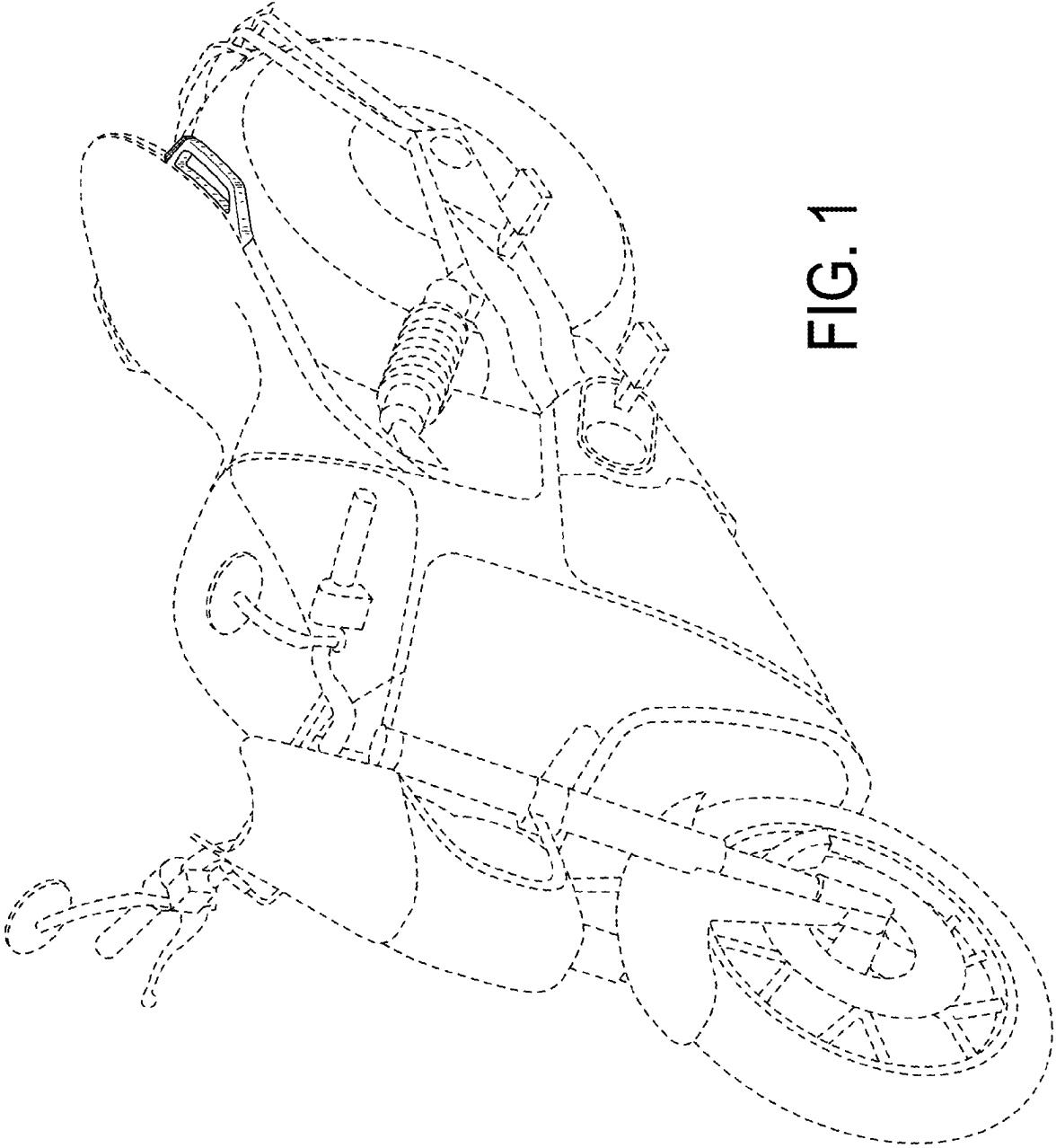

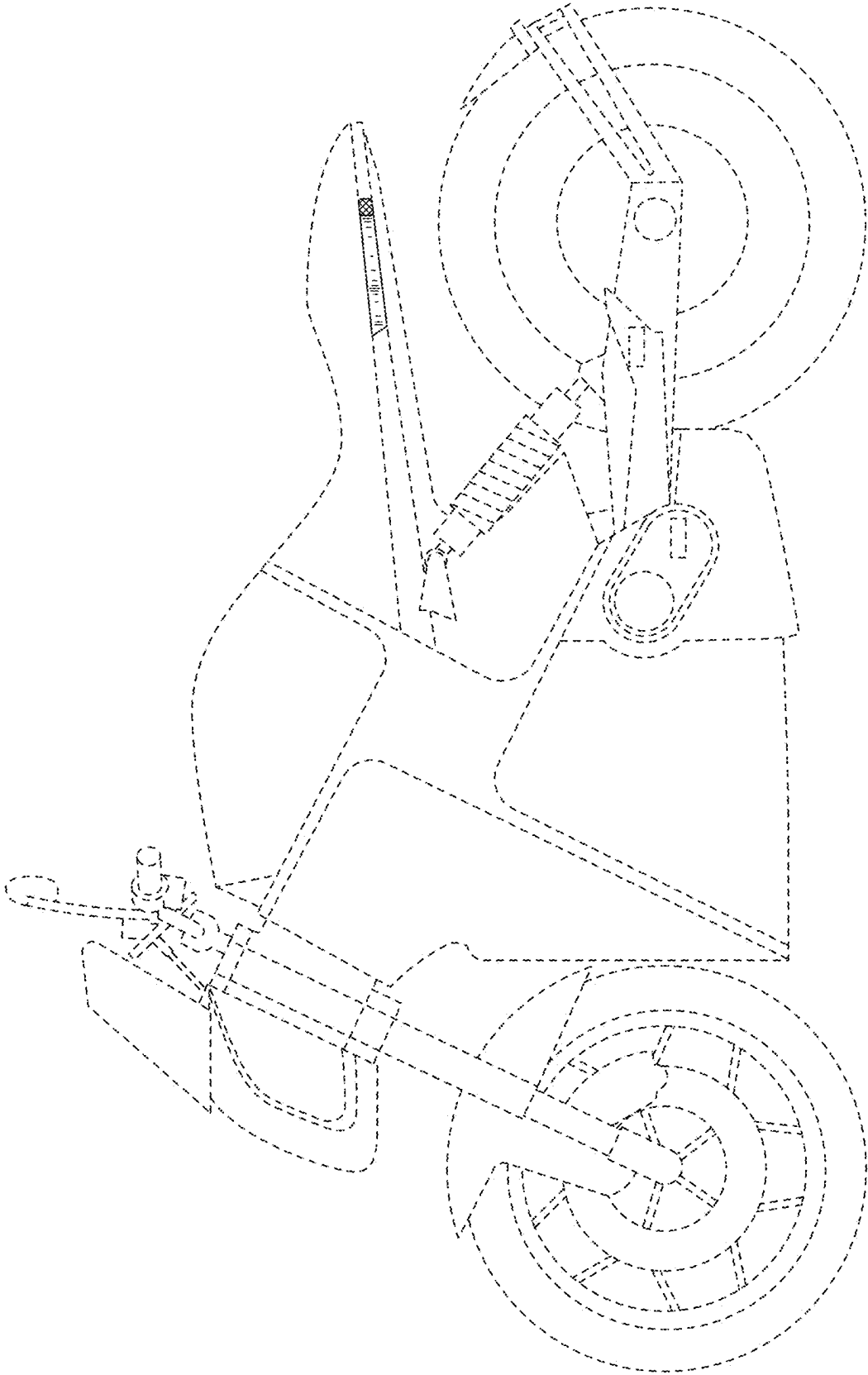

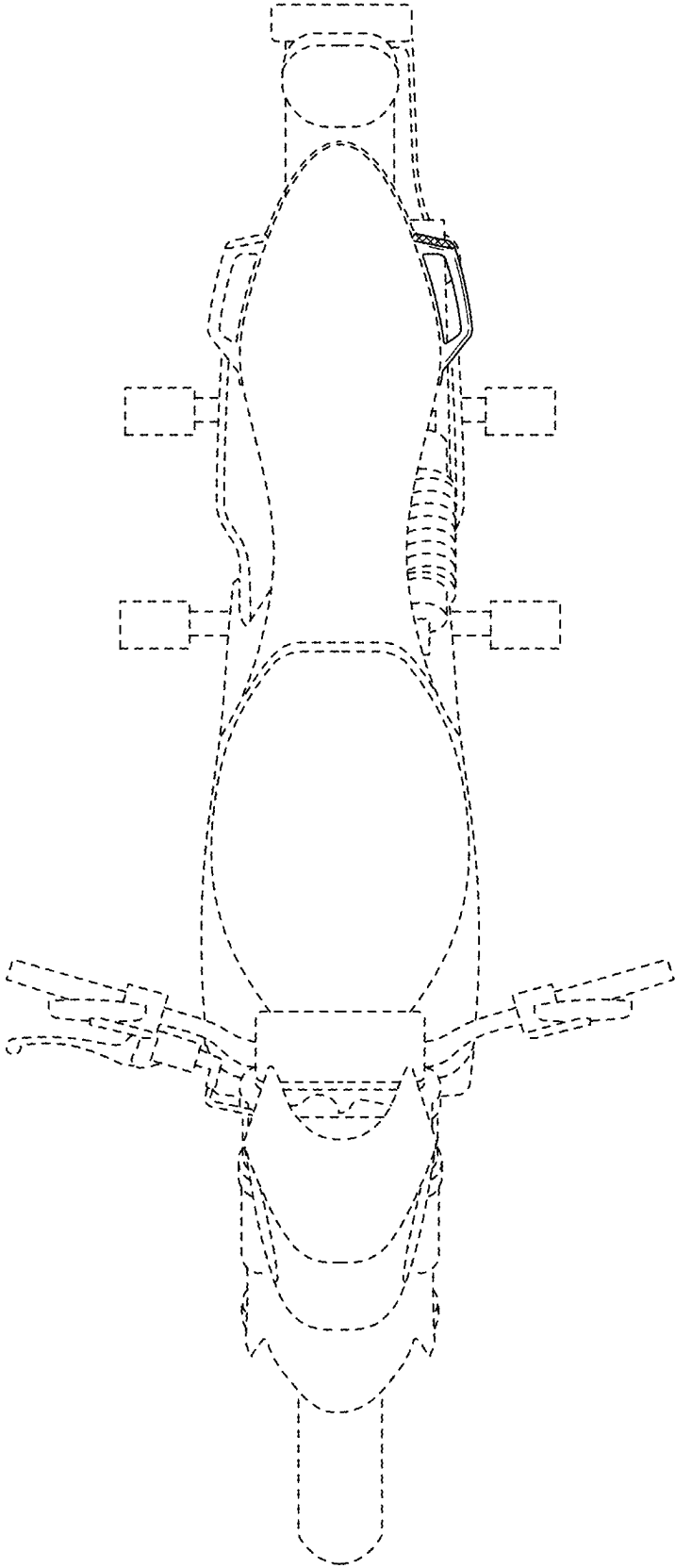
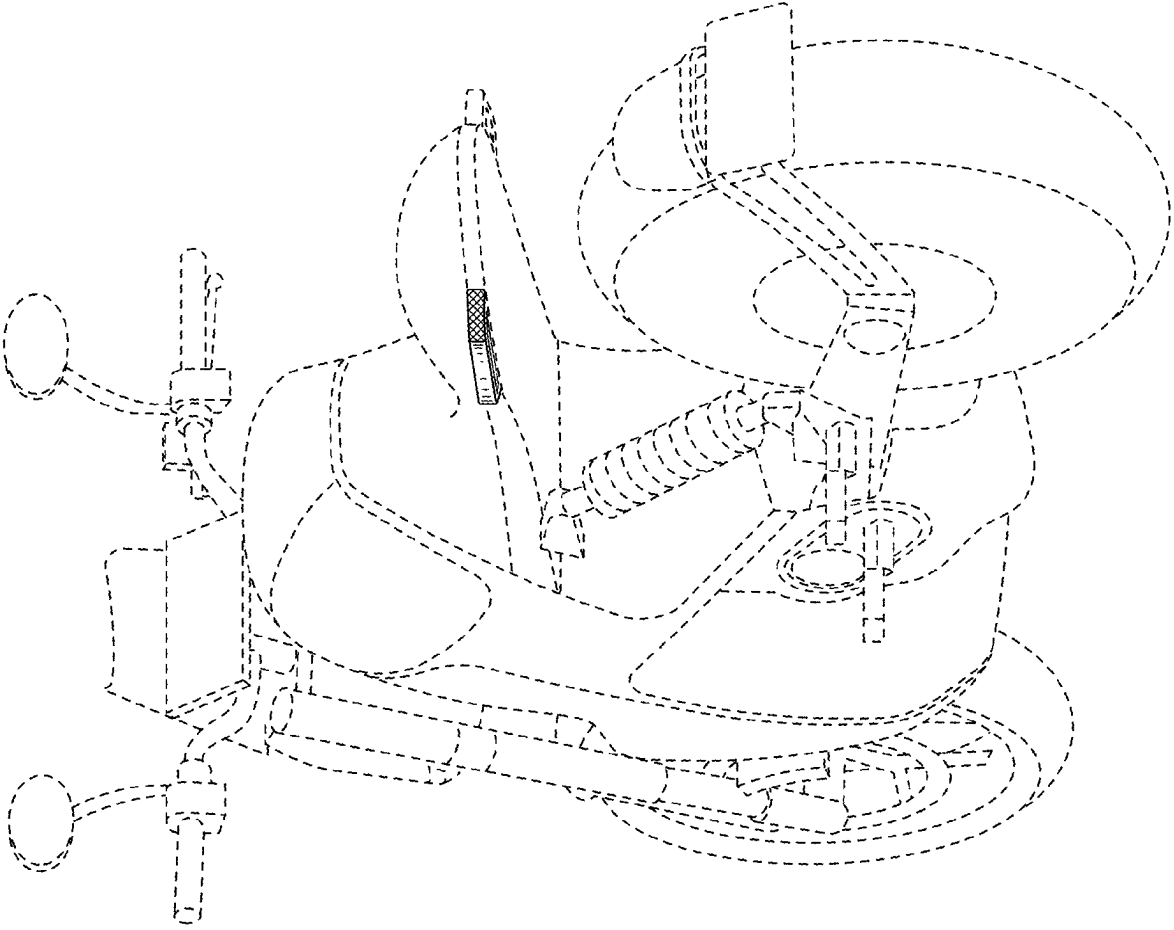

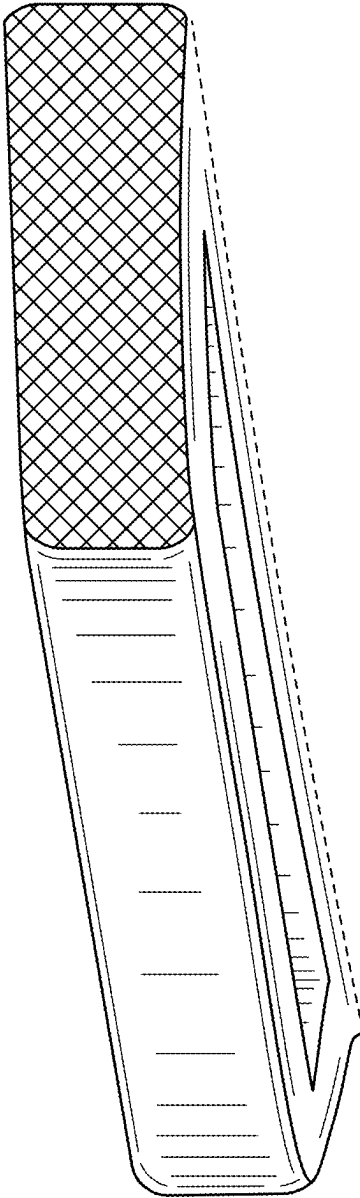
